Guidelines for Submissions of Articles

#### 1) Style and length

The length of feature articles should be between the range of 1200-1800 words (excluding the title of the article). Opinion pieces should not exceed 900 words. The Length of letters to the editor and writings on organizational activities should not be more than 500 words. Reviews on books are con sidered to be the length of opinion pieces. Music and technological reviews should be in the same range of words as letters to the editor.

#### 2) Submission dates

The Bottomline is a monthly publication and due dates for the publication will be released in the submission schedule. All articles sent 10 days before release will not be considered.

#### 3) Plagiarism and writing

All articles submitted should follow the principle of originality – meaning that the writings must be the ideas of the author. All cited sources should be referenced. We are less likely to publish articles that were published elsewhere unless the editorial board takes a contrary decision. Should you feel that your article will reach a wider audience or readership through Bottomline than where it was published, you can send the article to the editor.

#### 4) Themes

Different issues of the Bottomline have different themes (Youth Month, State Power, Gender struggles, etc) and some articles might be reserved for a specific theme.

#### 5) Articles review process

The Bottomline is publication aimed at advancing the ideas of the working class, especially young people. Therefore, articles written by young people and members of the YCLSA will be given special preference. All articles will go through a review process and the author will be informed of the review process before publication.

We now know through records of the Auditor General South Africa and other competent institutions including Corruption Watch which recently revealed that over seventy per cent [70%] of the corruption reported in local government were mainly from the DA controlled metro municipalities in Cape Town, Tshwane and Johannesburg. At this rate, it is vividly clear that the DA does not possess the requisite capacity to 'rescue South Africa'. Instead, South Africa should rescue the DA from racial superiority infused notions. Travelling in Cape Town during the SACP campaign led by the General Secretary, one could note features and elements of the separate development policy of Apartheid of the National Party which evolved into the DA.

The skewed development trajectory in the Western Cape resembles the spirit of this pieces of legislation that H.F Verwoerd even postulated that the Natives will be taught from childhood to realize that equality with Whites is not for them. There is no place for the Bantu child above the level of certain forms of labour. Sauer Report, 1948 recommendations culminated into legislations like Suppression of Communism Act, No 44 of 1950, Bantu Education Act ,No 47 of 1953, Reservations Separate Amenities Act, No 49 of 1953, Groups Areas Act,No 41 of 1950, Prevention of illegal squatting Act, No 47 of 1953 among others being enacted by the Apartheid government. It goes without saying that undertones of apartheid in development patterns are damaging on our young constitutional democracy.

It is therefore imminent that now more than ever, come the 29 May 2024, the working class should be determined, united in their resolute to defend the gains of our democracy, isolate, combat, defeat the inherent, domestic and international, old and new class adversaries of the peoples' national democratic revolution and RESCUE the Western Cape from the Apartheid proponents, beneficiaries and apologists in the form of the DA by voting the African National Congress (ANC). This is to ensure that Together, We do more towards addressing the imbalances of the past to usher social transformation and justice. Liberators do not exist; the people liberate themselves, as Che Guevara once postulated. However, workers' achievements are under attack. Collective solidarity is crucial in defending the hardwon achievements and tackling the inequality inherent in the capitalist system altogether with the system itself.

The most sustainable path forward is to unite and intensify the struggle to build socialism.

#### **Capitalist system crises**

As we reflect on the significance of International Workers' Day, it is crucial to acknowledge the profound impact of ongoing capitalist crises on workers and the poor in general. The capitalist crises are deepening, worsening working conditions, unemployment, income and wealth inequality, as well as poverty.

The capitalist class, supported by their political representatives, consistently seeks to transfer the aftermath of their system crises to the workers and the poor. They also enforce austerity measures, involving budget cuts. This affects workers, including women, and the poor in general. The bosses also cut the wage bill to protect and increase profits, forcing workers to bear the brunt of capitalist crises.

#### **Building workers' power**

The trade union movement and the SACP have been at the forefront of the struggles for workers' interests in both the public and private sectors. Together we have been campaigning for policies that advance the rights of the young people and women who are unemployed and are mostly the first victims of capitalist crises.

Together we remain opposed to budget cuts in development and social spending. Together we are opposed to attempts to privatise public assets, as in the case of South African Airways. We raised our voices and demonstrated against anti-trade union rights that undermine collective bargaining. Together, we campaigned against the rising cost of living, which affects workers' incomes.

Let us unite and intensify the working-class struggle on all fronts. The SACP will strengthen its alliance and joint efforts with Cosatu to organise the unorganised, deepen worker education and build the progressive trade union movement to be more united and stronger.

#### Vote ANC to defend and advance workers' achievements and struggle

The SACP calls on our people to vote for the ANC in the upcoming elections, on 29 May 2024. We say this for the following reasons, amongst others:

1)The ANC, along with the SACP and the Cosatu-led trade union movement, has actively worked hard to achieve, establish, protect, and promote democracy in South Africa. We have made significant improvements in the lives of South Africans, particularly the workers and poor, by providing essential goods and services such as housing, electricity, clean water, education, healthcare, and social grants. We have also championed a progressive constitution, which is against discrimination and upholds workers' rights.

2)The ANC is committed to addressing the problem of unemployment, especially among young people. The ANC has adopted a plan to create and sustain 2.5 million work opportunities through public employment programmes over the next five years. The ANC aims to prioritise local manufacturing, raise investment levels in various industries, support small businesses and cooperatives, and focus on intensifying skills development to build a people's economy, reduce inequality and tackle poverty.

3)The ANC has implemented policies to uplift the poor and marginalised communities. These policies include social grants, free basic services, affordable and free housing programmes, the national minimum wage and Unemployment Insurance Fund benefits. By voting for the ANC, workers will ensure the continuation and expansion of the pro-poor policies.

Already we have reached near-universal education attendance by children aged five and six. The ANC has also planned to open new universities and colleges in the next five years and invest in education and training to equip the working class with the necessary skills for sustainable employment and collective worker ownership in the form of cooperatives.

5)The ANC has been at the forefront of the struggle for accessible healthcare for all. It has made significant progress in providing free healthcare to pregnant women, and children under five years, combatting HIV/AIDS and COVID-19, improving healthcare facilities in rural areas and townships, and increasing life expectancy. The ANC's plans include implementing the National Health Insurance as law to ensure quality healthcare for all, regardless of their income status.

6)The ANC has shown leadership in global peace efforts. We reiterate our steadfast internationalist solidarity with the people of Palestine, who know that they are not alone in their suffering, resistance and struggle. In the east, west, north, and south of this globe, peace-loving people are more united than ever in solidarity with the Palestinians. We all demand an immediate ceasefire and an end to the ongoing crimes and genocide against the Palestinian people.

We reiterate our call for an end to the criminal blockade against Cuba. We express our support for the people of Swaziland struggling for democracy and the people of Western Sahara struggling for self-determination and against occupation by Morocco.

## **A Response to Phindile Kunene's Opinion Piece:** "Gutting of democracy goes beyond corrupt political interests"

Published by the Sunday Times on Sunday, 21 April, refers. The article correctly highlights the dichotomy of colliding interests between dominant market forces ("the market") on the one hand and the people on the other. However, Kunene propagates half-truths about the SACP. Her entry point is the "multi-party charter" electioneering slogans, which the educator at Friedrich-Ebert-Stiftung (FES) claims "remind us that corruption has destroyed our freedom and that we need not suffer from ANC-inflicted harm any longer". It is said elsewhere that a half truth is more dangerous than a lie. While a lie is easy to detect, a half-truth can mislead unsuspecting people for a long time.

Indeed, the SACP supported Zuma's candidature, culminating in his democratic election as the president of the republic in 2009. However, when Zuma betrayed the national-revolutionary democratic cause for which the SACP, the progressive trade union movement and other South Africans supported his candidature for in good faith, the party adopted a leading role in taking his tangential tendency head on.

While highlighting the SACP's initial support for Zuma, the educator concealed the party's widely recognised activism against the tangent he took. There can be no other reasonable conclusion than that her aim was to write off the SACP. She joins the bandwagon propagating the idea that the party's "credibility suffered a beating, while turning a blind eye to the sterling leadership role in tackling Zuma's tangent – whose details are documented in the Judicial Commission of Inquiry into State Capture report.

The SACP became the first organisation that exposed what it expressly characterised as corporate state capture in South Africa. In contradiction, Zuma and his lieutenants insisted that there was no such a thing. The conflict led to the SACP becoming the first organisation to call for the establishment of the commission. Parliamentary parties, including two of the right-wing opposition parties whose slogans Kunene praises, rejected the call pioneered by the SACP.

In prescribing that the commission be established, the Public Protector Thuli Madonsela in October 2016 arrived at the same conclusion as the SACP but introduced the provision that the chief justice must solely identify the judge for the president to appoint to lead commission. Only then, after this long time, did those who were opposed to the call express their support one after another.

Also, it is false that there is only one voice against neo-liberalism in South Africa. Needless to question the bona fides of that alleged voice, the fact is that the SACP's voice and campaigns against neo-liberalism are well known.

Similarly, it is misleading to turn a blind eye to the commendable advances implemented by the ANC-led government since 1994. Inevitably, the educator and programme manager at FES misconstrued the ANC's election slogan, "Let's do more, together", in juxtaposing it with those of the opposition parties. The fact is that millions of our people, the majority of whom is from working-class families, are benefitting from the progress introduced by the ANC-led government. Among others, over five million students benefitted from NSFAS funding.

It is unscrupulous to ignore the corruption scandals that hit Tshwane under the DA-led right-wing coalition, including the R26 billion unsolicited bid exposed through leaked recordings in 2021 and the R1 billion understated fruitless and wasteful expenditure exposed by the Auditor-General last year.
